By providing support at a community level we can end homelessness among the Veteran population. Through outreach, case-management services, assistance in obtaining benefits and emergency financial resources, the SSVF Program seeks to prevent Veterans and their families from becoming homeless and seeks rapid rehousing for those who are literally homeless.



## What Can SSVF Do?

- Outreach to Veterans who are homeless or at risk of homelessness
- Transportation and childcare services as it relates to stable housing
- Provide support through case management to increase skills and income of participants
- Temporary Financial Assistance (TFA) that directly leads to stable housing
- Provide skilled staff to help obtain VA and disability claims



### **Eligibility Requirements**

- An Veteran who served in the active military, naval, or air service
- Must not have received a dishonorable discharge
- Low-income according to program guidelines
- Homeless or at risk of homelessness
- Willing to participate in finding a solution
- Individuals and families are welcome

## To receive supportive services under this program you must:

- Have one family member in the household who served in the military
- A Veteran/family who lacks a fixed, regular, and adequate nighttime residence (e.g., entering an emergency shelter or place not meant for human habitation).
- Veteran residing in permanent housing and at risk of becoming literally homeless 'but for' SSVF or identify new housing that will better meet their needs and be sustainable.



### **Financial Assistance**

Temporary financial assistance may be available to veterans who qualify for the housing program and who would be homeless but for SSVF assistance. Help may include: rental assistance, utility payments, security deposits, moving costs, childcare, transportation expenses, and emergency housing stability needs.
